MINOR SCOPE OF WORK

1. Provision of BP Ultimate Diesel or equivalent product
2. The fuel price proposed shall be based on the last week of October 2025.
3. KML Mining Plant annual consumption: estimated up to 5,500,000 litres
4. Deliveries to site: between 4 or 5 deliveries per month. 80,000 litres per delivery
5. **Fill in the KML Diesel tanks:** KML owns 4 diesel tanks at the site.
6. Diesel tank capacities: 1x tank 102,000 litres; 2x tanks 116,000 litres; and 1x tank 37,000 litres.
7. Tank safe fill levels: 3 x 100,000 Litres and 1 x 37,000 litres.
8. In the event of adverse weather or road conditions, supplier should be able to provide a single trailer delivery as required.
9. The requirements for vehicles
 - 9.1. Meet WA heavy vehicle, flammable & dangerous goods standards” and have safety equipment, and drivers to complete site training,
 - 9.2. A DG vehicle licence/permit,
 - 9.3. DG driver licence/endorsement,
 - 9.4. DG transport documentation (placarding, load docs, SDS carriage),
 - 9.5. Emergency response guide (ERG) and spill kit carriage under ADG Code,
 - 9.6. Evidence of chain-of-responsibility compliance.

LOCATION | 位置

The work is located at Karara mine site in the Shire of Perenjori, the Midwest region of Western Australia. It is approximately 320 km north-north-east of Perth and 225 km east of Geraldton

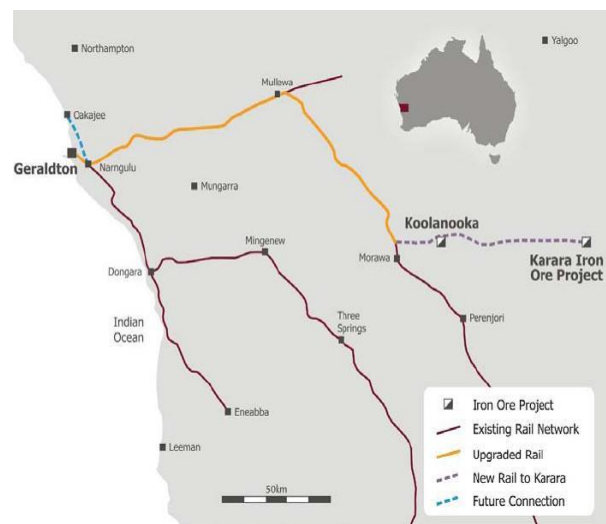

Access to the site from Geraldton is via the Geraldton-Mount Magnet Road to Mullewa, the Mullewa-Wubin Road to Koolanooka and then via a 60Km long, graded, unsealed track to the site.

从杰拉尔顿前往现场的路线为：沿 **Geraldton-Mount Magnet Road** 至 **Mullewa**，再沿 **Mullewa-Wubin Road** 至 **Koolanooka**，然后通过一段约 60 公里长的平整的未铺装道路到达矿区现场。

Access to the site from Perth or Fremantle is via the Great Northern Highway to Wubin, the Mullewa-Wubin Road to Koolanooka and then via a 60Km long, graded, unsealed track to the site.
