**2.0 PROJECT OVERVIEW | 项目概述****PROJECT OVERVIEW | 项目概述**

The Karara Mine Operations involves the integrated development of a world-class magnetite deposit at Karara to produce high-grade magnetite concentrate on-site for export to China.

卡拉拉矿业运营项目包括对卡拉拉世界级磁铁矿矿床的综合开发，以在现场生产高品位磁铁矿精矿并出口至中国。

Karara is a world-class ore body in terms of its scale, quality, consistency, and extremely low waste-to-ore stripping ratio, which results in relatively low mining costs.

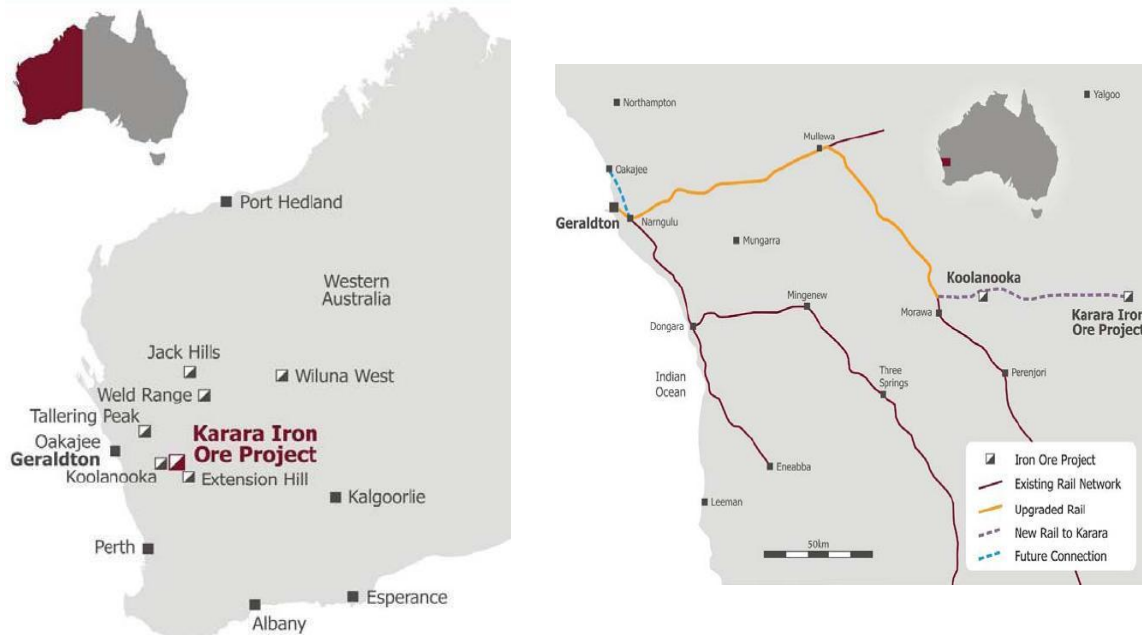

## 1. Information AND Deemed Warranty by Tenderers / 投标人提供的信息及推定保证

The information in this Request for Tenders is provided for the convenience of Tenderers. While Karara has taken reasonable steps to ensure that the information is accurate, it cannot and does not represent or guarantee the accuracy or completeness of the information.

The Tenderer may inspect the mine site at a nominated time and date as specified in **Item 3** of the Particulars or as authorised by Karara's representative. (Not applicable)

## 6. Process/招标流程

If Karara is satisfied with the tender process, it is the intention of Karara to select one or more preferred tenders from the submissions received and to then negotiate with the preferred Tenderer or Tenderers in relation to the terms of a written agreement that is acceptable to Karara.

## 7. No contract is binding until written and executed/合同须经书面形式并正式签署后方为生效

No agreement or contract of any kind will arise between Karara and any Tenderer unless and until the terms of a written agreement that are acceptable to Karara have all been reduced to writing in a single document and signed by both Karara and a successful Tenderer.

## 8. Tenders and Schedules/投标文件及附表

All tenders must be in writing in order to constitute a conforming tender and each Tenderer must complete each schedule to this Request for Tenders.

## 9. Late Tenders/迟交投标文件

Karara reserves its right to reject one or more late tenders and accept for consideration late tenders in its absolute discretion.

## 10. Tender Costs/投标费用

Tenderers shall meet all costs of preparing and submitting tenders.

## 11. Uncompetitive Behaviour/不正当竞争行为

By submitting a tender, each Tenderer warrants that neither it nor any of its personnel or related entities have engaged in any uncompetitive behaviour or any other practice which denies or may deny legitimate business opportunities to other Tenderers or other participants in the tender process including, but not limited to, the following:

### 11.1 Information - Pricing Schedules/价格表信息

## 12. Completion of Tenders/投标文件的完整性

It is the responsibility of the Tenderer to ensure that all parts of this Request for Tenders document issued by Karara have been received and it is the Tenderer's responsibility to raise any queries concerning apparent ambiguities, contradictions or conflicting information.

## 13. Clarification of Tenders/投标澄清

The Tenderer may seek clarification of any part of this Request for Tenders from Karara. Questions should be directed in writing to the contact person identified in the covering letter.

Karara may, on request, clarify aspects of this Request for Tenders in writing but is under no obligation to do so. Clarification responses by Karara may be distributed to other Tenderers in the form of an addendum to the Request for Tenders or in such other form as Karara sees fit.

## 14. Tenderers to Inform Themselves/投标人自行了解情况

Without limiting anything else in this document, on submission of a tender, Tenderers shall be deemed to:

- have examined and understood the Request for Tender documents and any other information made available by Karara to the Tenderer for the purpose of considering or submitting its tender;
- 仔细审阅并理解本招标文件及卡拉拉向投标人提供的所有相关信息；
- have examined and be fully aware of all information that could have been obtained by the making of reasonable inquiries relevant to all risks, contingencies, facts and circumstances that could affect the efficacy of the tender and the Tenderer's ability to provide the Diesel Light Tower;

- be satisfied as to the correctness and sufficiency of their tenders including proposed fees and all matters and things necessary for the due and proper use of mine and performance of the Mining Services. Tenderers must raise any queries, clarify issues or requirements and generally have a full understanding of the Request for Tender before submitting tenders;

## 15. Tenderer Interview /投标人面试

Karara may require one or more Tenderers to attend interviews at Karara's offices during the tender assessment period. The Tenderer shall bear all costs incurred by it in attending the interviews. Alternative arrangements (such as video conferencing) for overseas or interstate Tenderers may be arranged if Karara considers them appropriate. In addition, Tenderers may be asked to give an oral presentation to further explain the tender.

## 16. Tenderer's Identity and Joint Venturers/投标人身份及合资企业投标

The identity of the Tenderer is fundamental to Karara. The Tenderer shall be the corporation or other legal entity named as the Tenderer and whose execution appears on the Executed Form of Tender.

投标人的身份对卡拉拉至关重要，投标人必须是投标文件上所列的法人实体，并在投标函中签字确认。

A tender submitted by a joint venture or partnership shall comply with the following requirements:

- a copy of the agreement entered into by the joint venture partners shall be submitted with the tender.

### 17. No Assignment/禁止转让

By submitting a tender, each Tenderer will be deemed to have agreed that its tender is personal to and is not capable of being assigned or transferred by, the Tenderer or any representative of the Tenderer.

提交投标文件即表示投标人同意，其投标文件不得由投标人或其代表转让或转移给任何其他方。

### 18. No Masquerades /信息披露要求

If the Tenderer is acting as agent or trustee for or jointly with another person, persons, corporation or corporations this must be fully disclosed by the Tenderer in the tender. If the Tenderer fails to fully disclose the identity of all participants and the nature of its relationship to those participants, the Tenderer's tender may not be considered by Karara. No one will have any right, title or interest in any agreement that arises out of the tender process unless they have been fully disclosed to Karara in the relevant tender.

### 19. Ownership of Tender Responses/投标文件的所有权

All documents, materials, articles and information submitted by the Tenderer as part of, or in support of a tender shall become, upon submission, the absolute property of Karara and will not be returned to the Tenderer at the conclusion of the tender process. However, the Tenderer shall be entitled to retain confidentiality regarding its submission, copyright and other intellectual property rights therein, unless otherwise provided in any agreement that arises out of any tender.
